Joseph Nyuma Boakai, Sr., Liberia is focused on fostering unity and progress, with the rallying call, "Think Liberia, Love Liberia, Build Liberia." Liberia has also made historic strides in leadership, becoming the first African nation to democratically elect a female president, Ellen Johnson Sirleaf, a Nobel Peace Prize laureate recognized for her contributions to peace and women's empowerment. Later, George Weah, a former football icon and the only player to win Africa's, Europe's, and the World's Best Player titles, became president, showcasing the diverse talents of its leaders.

Liberia is home to trailblazing figures like Angie Brooks-Randolph, the first African woman to preside over the United Nations General Assembly, further solidifying its global legacy. With lush landscapes, vibrant culture, and resilient people, Liberia continues to celebrate its pivotal role in African history while striving for a brighter future.

Liberia has been a founding member of the United Nations since 1945 and has served on the UN Security Council in 1961. However, under the leadership of H.E. President Joseph Nyuma Boakai, Sr., and through the Foreign Minister, H.E. Sara Beysolow Nyanti, Liberia is now bidding for a seat on the UN Security Council for the 2026-2027 term.

It also highlights the nation's rich natural resources, offering visitors a glimpse into Liberia's tropical rainforests, vibrant cultural heritage, and diverse investment and business opportunities.
